The Stanton Dental Care Center opened in September 2000 to serve the children and adults of Montcalm County who are Medicaid recipients. As of Oct. 1, 2003, Medicaid dental benefits for adults were eliminated and the Stanton Dental Care Center now serves only children.

The Montcalm Area Schools Basic Dental Screening, conducted in Montcalm County, screened 907 elementary school children in Montcalm County:

- 66% of 2nd-graders were determined to have a history of cavities
- 31% of 2nd-graders were determined to have untreated cavities
- 8% of those examined were in need of urgent dental care (infection, etc.)
- 15% of the children were reported to have had multiple toothaches in recent months

FOUNDATION TAX CREDIT

A 50% direct Michigan personal income tax credit or Michigan single business tax credit applies to all gifts to certified community foundations up to: \$100 for individual taxpayer who is single or married and filed separately; \$200 for a married couple filing jointly; \$5,000 or 10% of the tax liability before any credits (whichever is less) for resident estate or trust; \$5,000 or 5% of the tax liability before any credits (whichever is less) for businesses filing single business income tax returns.
