Dear Director Cheatham,

Thank you for your and Mr. Pope's time this afternoon joining Mark Paepcke and me in a conversation about your department's accreditation status.

As discussed, we are offering to extend your current accreditation status for one year, through March 31, 2022. This means that your deadline for deciding to apply for reaccreditation will be approximately one year from now. We are offering extensions of up to one year to health departments because we wish to be as responsive and supportive to accredited health departments' needs as we can during this crisis, especially given the significant staffing issues that many departments are facing. I am hopeful that new, sustainable federal funding resources will be made available to health departments within the next year to address public health infrastructure, including the costs of achieving and maintaining national public health accreditation. I will share information about the federal legislation that is going to be introduced under separate cover.

We are asking departments to pay a fee of \$850 if they are seeking to extend their accreditation status for a year. This \$850 will meet our direct costs for maintaining the e-PHAB software license for your department and for your access to our Accreditation Specialist as needed, as well as any education offerings we will provide to accredited health departments. We will invoice you after we hear from you that you would like to have the extension.

Thank you, again, for your communications with us. And thank you for all you have done, and are doing, to protect and promote the health of your community!

Dear Director Cheatham,

I am writing in follow up to the email exchange (below) between Ms. Jimenez and Mr. Pope regarding Mid-Michigan District Health Department's accreditation status. I would like to request a video conference call with you at your earliest convenience to better understand your decision to not seek reaccreditation.

We wish to be as responsive and supportive to accredited health departments needs as we can during this crisis, especially given the significant staffing issues that many departments are facing. I would deeply appreciate the opportunity to hear from you directly about your circumstances and understand why you are choosing to discontinue your national accreditation. My hope is that we could find a solution to maintain your status for now and defer a decision on pursuing reaccreditation for a period of 9 or 12 months to get on the other side of the demands of the surge in COVID cases and the anticipated mass vaccination program.

If, however, you are firm in your decision not to apply for reaccreditation, the PHAB Accreditation Committee will meet on February 12, 2021 and likely vote to designate your health department as No Longer Accredited— Accreditation Expired. Loss of your accreditation status means that you would no longer be able to use the "PHAB Accredited" seal on your website, stationery, business cards, or any other health branding that you may have. In addition, you would not be able to present your health department in any manner as an accredited health department. This change in your accreditation status would be shared with the Michigan Department of Health and with the CDC. Should you decide to pursue accreditation in the future, you would need to reapply as a new applicant and go through the initial accreditation process.
