

COMMUNITY HEALTH PROGRAMS

Women, Infants and Children (WIC)

Provide breastfeeding support, referrals to community resources, nutrition education and food benefits to qualified women, infants and children up to age 5.

Immunizations

Provide vaccinations for all ages as well as educational sessions to health care providers. Provide day care and school health immunization compliance.

Family Planning

Provide birth control education, physicals and supplies for males and females, as well as pregnancy testing and counseling.

Hearing and Vision Screening

Provide hearing and vision screening for preschool and school-age children, as well as referrals to providers.

Children's Special Health Care Services

Medical advocacy and financial assistance to children with qualifying medical conditions.

Communicable Disease Control

Investigate diseases to prevent the spread in the community and inform those who may have been exposed.

Sexually Transmitted Infections (STI)

Provide STD testing, treatment and counseling; and partner notification and follow-up.

HIV Counseling and Testing

Provide confidential testing.

Pathways to Better Health

Connects clients to health and social service resources and programs to improve their lives and their health.



Blood Lead

Provide blood lead screenings, education and case management

Breastfeeding Consultation and Support

Provide breastfeeding support and education to women.

Oral Health Initiatives

Provide fluoride varnish, education, and assessments to preschool and school-age children.

Health Education

Collaborate with community groups and agencies to promote healthy lifestyles. Provide resources and information on public health topics.

Breast and Cervical Cancer Control

Provide physical exams, pap smears and mammograms to uninsured women.

Tuberculosis (TB) Control

Provide TB skin testing, medication and monitoring.

Emergency Preparedness

Work with community partners to prepare for and coordinate response to emergencies.

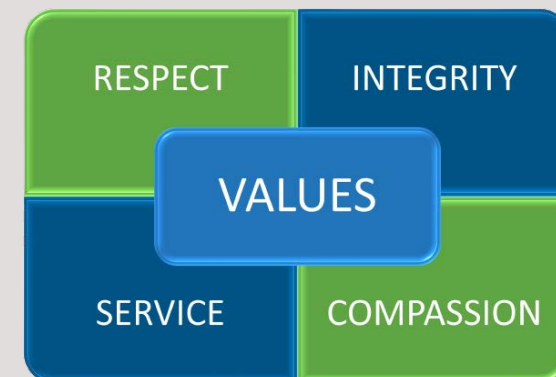

Septage Waste Haulers

Regulate the service of septic tanks and portable toilets and the transport of septage waste.

Water Wells

Issue permits for water supply systems. Protect groundwater quality. Conduct water sampling.

Public Swimming Pool Program

Regulate public swimming pools, spas and hot tubs.

Unsanitary Condition Investigation

Investigate nuisance complaints.

Loan Evaluations

Perform water supply and sewage disposal evaluations for compliance.

Campground Inspections

Perform annual campground inspections.

Other

- Provide radon test kits.
- Investigate mercury spills and provide consultations for proper disposal.
- Evaluate plats/subdivisions relative to State statutes.
- Regulate body art facilities for compliance.
- Inspect medical waste facilities to assure compliance.
- Inspect child and adult facilities for compliance.
- Sharps disposal.

ENVIRONMENTAL HEALTH PROGRAMS

Food Service Sanitation

Provide educational food safety programs. Inspect and license food establishments. Review new food service establishment plans and investigate complaints.

Sewage Disposal

Prevent exposure to untreated wastewater. Issue permits for installing or repairing sewage disposal.
