G. Bailey called the Finance Committee Meeting of the Mid-Michigan District Board of Health (BOH) to order at 8:31 a.m., on Wednesday, October 22, 2025, at the Montcalm Office of the Mid-Michigan District Health Department (MMDHD), Stanton, Michigan.

Motion made by B. DeLong to approve the agenda as presented A. Petersen seconded. Motion carried.

- A. MMDHD's Expenses for September 6 through October 4, 2025
 - G. Bailey went over the expenses, asking the board if there were any questions.
 - B. DeLong questioned a couple outgoing payments; a check made out to an individual was explained by S. Doak this is a person contracted to run a coalition for Drug Free Community in Clinton County noting there will be a 1099 issued. Payment to Winn Telecom Communication was questioned as to what the service was provided and why it indicated multiple months, M. Selby explained this was a telephone service and the multiple months are due to our account having a credit in months past. A. Peterson also questioned what STAT Courier service was for L. Smith said this is how the water

samples are transported to the lab for testing and noted the service saves the agency on postage and ensures the samples are received in the required timeframe for testing.

Motion made by B. DeLong to recommend the BOH approve and pay the MMDHD's Expenses for September 6 through October 4, 2025, totaling \$684,314.55, A. Petersen seconded. Motion carried.
